Weaver Creek Restoration Project Field Tour

## Tuesday, December 12th 1pm to ~3pm

Restoration features will be presented followed by Q&A.

Land Acknowledgement: The project is located on the ancestral lands of the Nor Rel Muk Wintu people.

Brief Project Description: Yurok Tribe Fisheries Department Design & Technical Services Program, in partnership with the Nor Rel Muk Wintu Nation, is developing a design to create instream habitat and new floodplain areas along this 1.5 mile section of Weaver Creek to: significantly increase the amount of instream habitat for coho salmon that are listed as a threatened species; improve riparian habitat while controlling the spread of invasive plant species; and ensure a single threaded wet channel during summertime baseflow conditions so that water is likely to remain available instead of going subsurface or evaporating. Numerous new habitat features are proposed including new floodplain areas, a secondary channel, constructed riffles, and wood loading. Designs are at a 60% design level and are actively being developed.

Note: The project area has a fair amount of uneven, often rocky terrain and may be wet and slick, as is common during the wet season. Please dress warmly and in suitable footwear.
